

AuthorizationHub Terms of Service

Last updated: September 30, 2025

By purchasing, installing, or using AuthorizationHub (“Software”), you agree to these Terms of Service (“Terms”). If you do not agree to these Terms, do not use the Software.

1. Definitions

- **“AuthorizationHub LLC”, “we”, “our”, or “us” refers to AuthorizationHub LLC, based in the State of Illinois, USA.**
 - **“Software” refers to AuthorizationHub, a C# library designed for implementing claims-based user authorization in multi-user and multi-organization web applications.**
 - **“You” or “your” refers to the person or entity that has licensed the Software under these Terms.**
 - **”Site” or “Website” refers to AuthorizationHub.com, and related websites that provide documentation, the downloadable Software, marketing information, and subscription management services.**

2. License Types and Scope

AuthorizationHub is licensed—not sold—under the following commercial license tiers:

- 1. Single-Tenant License ($\leq$ 1,000 users):**
For applications that serve as a single tenant with up to 1,000 users. You may create one tenant to serve as the root of an organizational tree to provide user claims for application security policies for a single application.
- 2. Single-Tenant License (Unlimited users):**
For applications that serve as a single-tenant application with no restriction on the number of users. You may create one tenant to serve as the root of an organizational tree to provide user claims for application security policies for a single application.

3. Multi-Tenant License (Unlimited users):

For applications that serve as a multiple tenant application with no restriction on the number of users. You may create multiple tenants to serve as the roots of organizational trees to provide user claims for a single application.

Each license is valid for one (1) application only. Deploying the Software across multiple applications requires a separate license for each.

You may not:

- **Use a license across more than one application.**
- **Circumvent user or tenant limitations by any means.**
- **Re-sell, sublicense, or redistribute the Software.**

License Activation and Expiry

All licenses are time-bound and expire at the end of your billing period (monthly or annually). After each successful renewal, you are responsible for manually downloading and applying a new license file. The Software will cease to function once the current license expires, until a valid new license is installed.

3. Account Responsibility

You are responsible for managing access to your Software license and any associated keys or credentials. AuthorizationHub LLC is not liable for any loss or unauthorized use resulting from your failure to secure your license credentials.

4. Payments, Billing, and Renewals

- **Licenses are offered on a monthly or annual subscription basis.**
- **Billing starts immediately upon license activation and renews automatically unless canceled.**
- **If payment fails or is not completed, your license may be suspended or terminated.**
- **Upon successful renewal of your subscription, you are responsible for obtaining and applying a new license file. AuthorizationHub LLC does not**

automatically deliver renewed licenses. If a new license is not applied after renewal, the Software will cease to function.

- All fees are exclusive of any taxes, levies, or duties imposed by taxing authorities. Where required, we will collect those taxes on behalf of the taxing authority and remit those taxes to taxing authorities. Otherwise, you are responsible for payment of all taxes, levies, or duties.

5. Refund Policy

All sales are final. AuthorizationHub LLC may, at its sole discretion, offer a refund for certain cases within the first 30 days of purchase. No refunds will be issued for partial use, unused time, or license misuse.

6. Cancellation and Termination

You may cancel your subscription at any time through the license portal or by contacting support. Cancellation stops future billing but does not trigger a refund.

AuthorizationHub LLC may suspend or terminate your license immediately if you:

- Violate these Terms;
- Fail to pay;
- Use the Software in a prohibited or unlawful way.

Upon termination:

- You must cease all use of the Software.
 - Destroy all copies in your possession.
 - AuthorizationHub LLC will revoke access to license keys or future updates.

You may not:

11. Security and Updates

AuthorizationHub LLC may issue software updates, patches, or security advisories from time to time. While we aim to support prior versions, we may require you to update in order to maintain security and license compliance.

We do not guarantee any specific uptime, support response time, or forward compatibility.
