NOTIFICATION

Dated Dispur, the 01st March, 2000

NU.FRW-55/99/70 : In view of the approval by Government of India vide its letter No.F. No.1-11/98-Pt. dated 11-2-2000, the Governor of Assam is pleased to declare the area described in the schedules below as a 'Tiger Reserve' under the Central scheme of 'Project Tiger'.

B. Boundary description

Core Area : The existing Nameri National Park notified vide No.FRW.11/96/81, dated 13-8-98.

Buffer Zone : (a) The whole of that part of the notified area of Naduar Reserved Forest notified vide No.5 of 17-10-1878 falling towards east of existing Nameri National Park up to the Ghiladhari River totalling 80 Sq. Km.

(b) The whole of that part of the notified area of Balipara Reserved Forest notified vide No.5 of 27-10-1878 falling towards west of existing Nameri National Park up to the Rangapara - Bhalukpong railway line totalling 64 Sq.Km.




