Awz Privacy Policy

Awz Ventures Inc. and its affiliates ("Awz", "we", or "us") value and respect your privacy. We have prepared this privacy policy to explain the manner in which we collect, use and disclose personal information (defined below) through website located "Website"), https://www.awzventures.com/ (the our online portal located at https://awzventures.altareturn.com/ ("Service"), and through other face-to-face meetings, telephone conversations and electronic or virtual communications with you, and when you otherwise interact with us.

COLLECTION AND USE OF PERSONAL INFORMATION

In connection with private placements of interests in investment vehicles controlled or managed by Awz, Awz may collect identifiable information ("personal information") about its investors and prospective investors.

Business Operations: If you enter into a subscription agreement with Awz in respect of a subscription for an interest in an investment vehicle controlled or managed by Awz, we may collect personal information such as your first and last name, residential address, telephone number, email address, tax identification number, subscription amount, investor status and information about your income, financial information required to make an investment, and other "know your client" information for identity verification purposes required under applicable laws including the *Proceeds of Crime (Money Laundering) and Terrorist Financing Act* (Canada), regulations and policies made thereunder and other statutes and regulations that take legislative measures against money laundering, terrorist financing and against financial dealings with certain sanctioned individuals and entities. This information will be used by Awz for the following purposes:

- processing the investment, opening and servicing client accounts;
- verifying identity and other information provided to Awz (including information about your bank account);
- if applicable, reporting the investment to the relevant securities regulatory authority;

- completing applicable books and records information in connection with the investment;
- detecting and preventing fraud and other unauthorized or illegal activities; and
- meeting other legal and regulatory requirements.

Awz may also collect information about the directors, officers, managers and other relevant individuals involved in Awz investments in the course of conducting due diligence regarding negotiating and closing such Awz investments. If you provide us with personal information about any other individual (such as your directors, officers, managers or other relevant individuals), you confirm that you have obtained the consent of such individual(s) prior to providing any personal information to us.

Create an Account: If you register or create an account to use the Service, we collect your email address and a password you choose in order to create and administer an online account for you and provide you with access to our online portal. We strongly recommend that you do not disclose your password to anyone. We will never ask you for your password in any unsolicited communication (such as letters, phone calls or email messages). If you become aware of any unauthorized access to or use of your account, you are required to notify us immediately.

Marketing Communications: If you sign up to receive email marketing communications, we will collect your name and email address in order to send you newsletters and other information about Awz that may be of interest to you. You can unsubscribe at any time by clicking the "unsubscribe" link included at the bottom of each email. Alternatively, you can opt-out of receiving email marketing communications by contacting us at the contact information provided in the "Contact Us" section below. Please note that you may continue to receive transactional or account-related communications from us.

Events: If you attend one of our events, we may collect business contact information such as your first and last name, company name, work email address and phone number or other personal information, including your government-issued identification where required by the venue. We collect this information so that we can reserve your spot for the event, organize and communicate with you about the event and contact you about future events.

Investor Calls: We may record investor calls that are held virtually with clients (or other individuals) for informational purposes. You will be provided with a notice at the beginning of any call that is being recorded. If you do not wish to have your call recorded, please let us know.

Surveys and Customer Research: From time to time, we may offer clients or other individuals the opportunity to participate in one of our surveys or other client research. The information obtained through our surveys and research is used in an aggregated, non-personally identifiable form to help us understand our clients and to enhance our online portal or product and service offerings.

Careers: In connection with a job application or related inquiry, you may provide us with certain personal information about yourself (such as that contained in a resume, cover letter, or similar employment-related materials). We use this information for the purpose of processing and responding to your application for current and future career opportunities.

Contact Us: When you contact us with a comment, question or complaint, you may be asked for information that identifies you, such as your name and email address, along with additional information we need to help us promptly answer your question or respond to your comment. We may retain this information to assist you in the future and to improve our client service, online portal and product and service offerings.

DISCLOSURE OF PERSONAL INFORMATION

We do not sell, disclose, trade, rent, transfer or otherwise disclose your personal information, without your consent, except as set forth below or as required or permitted by law.

Securities Laws: Investors' personal information, including the number of and purchase price for securities purchased, may be disclosed to the relevant Canadian securities regulatory authorities and become available to the public in accordance with the requirements of applicable securities and freedom of information laws. Each investor consents to and authorizes such indirect collection of the disclosure of personal information and acknowledges that: (i) the personal information is being collected indirectly by the applicable Canadian securities regulatory authority under the authority granted to it in securities legislation; (ii) the personal information is being collected for the purposes of the administration and enforcement of applicable Canadian securities legislation; and (iii) investors have been notified of the title, business address and business telephone number of the public official in their jurisdiction in the subscription agreement.

Service Providers: Your personal information may be transferred (or otherwise made available) to certain third parties in Canada, the U.S., Israel or other jurisdictions that provide services on our behalf. We use service providers to provide services such as verifying personal information (such as identity and bank account number) and other know-your-client information provided by clients, administering the Awz investments, hosting the Website, processing payments, organizing and booking events, sending email or other communications. In the event personal information is transferred to the US or other foreign jurisdiction, it will be subject to the laws of that jurisdiction. Our service providers are only provided with the information they need to perform their designated functions and are not authorized to use or disclose personal information for their own marketing or other purposes.

Legal and Compliance: We and our Canadian, U.S., Israeli, and other foreign service providers may provide your personal information in response to a search warrant to other legally valid inquiry or order, or to another organization for the purposes of investigating a breach of an agreement or contravention of law or detecting, suppressing or preventing fraud, or as otherwise may be required or permitted by applicable Canadian, U.S., Israeli, or other law or legal process, which may include lawful access by U.S., Israeli, or foreign courts, law enforcement or other government authorities. Your personal information may also be disclosed where necessary for the establishment, exercise or defence of legal claims and to investigate or prevent actual or suspected loss or harm to persons or property.

Sale of Business: We may transfer any information we have about you as an asset in connection with a proposed or completed merger, acquisition or sale (including transfers made as part of insolvency or bankruptcy proceedings) involving all or part of Awz or as part of a corporate reorganization or other change in corporate control.

INFORMATION ABOUT OUR WEBSITE

Visiting our Website: In general, you can visit our Website without telling us who you are or submitting any personal information. However, we and/or our service providers collect the IP (Internet protocol) addresses of all visitors to our Website and other related information such as page requests, browser type, operating system and average time spent on our Website. We use this information to help us understand our Website activity and to monitor and improve our Website.

Cookies: Our Website uses a technology called "cookies". A cookie is a tiny element of data that our Website sends to a user's browser, which may then be stored on the user's hard drive so that we can recognize the user's computer or device when they return. You may set your browser to notify you when you receive a cookie or to not accept certain cookies. However, if you decide not to accept cookies from our Website, you may not be able to take advantage of all of the Website features.
