Dear Chair, dear Bernd,

The Committee on Budgets and the Committee on Budgetary Control, in accordance with Rule 129 of the Rules of Procedure of the European Parliament, held a public confirmation hearing on 7 November 2024 with Mr Piotr Serafin, Commissioner-designate, who, subject to the positive outcome of the nomination procedure, will be responsible for Budget, Anti-Fraud and Public Administration.

On 16 October 2024, the Committee on Budgets and the Committee on Budgetary Control, pursuant to Rule 129 of the Rules of Procedure and Article 2 of Annex VII thereto, received the letter from the Chair of the Committee on Legal Affairs regarding the scrutiny of the declaration of financial interests of Mr Piotr Serafin.

Prior to the confirmation hearing, Parliament had sent the Commissioner-designate a list of written questions. Our committees noted that Mr Piotr Serafin answered those questions in a satisfactory manner.

The course of the confirmation hearing is described in the verbatim transcript of the proceedings.

On the basis of the responses of the Members present at the confirmation hearing, as well as the comments made by our committees' coordinators, who met in camera after the confirmation hearing under our chairmanship, we hereby give the following assessment:

During the hearing, Mr Serafin gave a positive impression to the Members. He presented a clear picture of the portfolio which he has been assigned.

Members appreciated his commitment to act as an honest broker, ensure equal treatment and access of information to Parliament and the Council.

Members took note of his vision for the next MFF and welcomed the commitment to preserving cohesion policy and ensuring a key role for regional and local authorities in its design and delivery, simplifying rules for final beneficiaries, enhancing flexibility, and reviewing and implementing the mainstreaming architecture, including the methodologies.

Members also appreciated his commitment to uphold the highest standards of control of the EU budget and protection of the financial interests of the EU, in particular by strengthening the anti-fraud architecture.

In the area of own resources, he also committed sparing no effort to convince Member States in the Council to make progress on the introduction of new revenue for the EU budget necessary to finance EU political priorities.

On the rule of law conditionality mechanism, Members expect the Commissioner-designate to fully apply the provisions of the regulation and to take all appropriate measures in case of serious risks affecting the sound financial management of the EU budget or the protection of the financial interests of the Union in a sufficiently direct way.

On the basis of the above assessment, the general outcome of this confirmation hearing is that the Commissioner-designate gave a convincing impression of his aptitude to be a member of the College of Commissioners and to carry out the specific tasks assigned to him.

In accordance with Rule 129 of the Rules of Procedure and Article 5 of Annex VII thereto, the BUDG and CONT coordinators representing a large majority of at least two thirds of committee members belonging to a political group approved that the Commissioner-designate Piotr Serafin, is qualified both to be a member of the College of Commission and to carry out the specific tasks assigned to him.

During the evaluation meeting, the coordinators of Patriots for Europe and The Left requested to put on the record minority views (see annex).

Minority views

Patriots of Europe

For the Patriots of Europe's political group, the nomination of the Commissioner-designate Piotr Serafin is strongly unacceptable given his view on the rules of law and on the conditionality principle.

Piotr Serafin has repeatedly stated that he will base his actions on European law and jurisprudence. In reality, this means entrusting crucial decisions to politicised judges, whose choices will be masked behind legal arguments, posing a major risk to the independence of the Member States

The Left

The Left Group does not support Piotr Serafin because the candidate has not been able to ensure an approach to the budget and to the new MFF after 2027 that stands for political priorities in the financing of cohesion, public services, housing, productive sectors or support SMEs. On the contrary, he has supported policies that abandon these objectives, opting to divert budgetary resources to objectives that are contrary to the interests of the people, namely supporting the privileges of large transnational corporations and without proper responses for the SMEs.

He also has not explained how its proposals to increase national contributions to the EU budget and strengthen own resources can be reconciled without undermining the redistributive nature of the budget.

The link between the disbursement of funds and the implementation of structural reforms remains a deep concern of the new EU budget model defended by Mr Serafin.

The Commissioner-designate did not compromise on the inclusion and enforcement of social clauses in access to EU funds or the exclusion of companies that do not respect labour and social standards.
