# ORDER

The Petitioner, Reliance Infrastructure Ltd. has filed the present petition under Section 86(1)(f) of the Electricity Act for directions to the Respondent, Government of Goa to take over the network laid down by the Petitioner Reliance Infrastructure Limited for supply of electricity to consumers in the area of supply in which the Respondent holds a license under Section 14 of the Electricity Act, 2003, in view of a dispute arisen between the Petitioner and the Respondent under Power Purchase Agreement dated 10.01.1997; and related matters.
