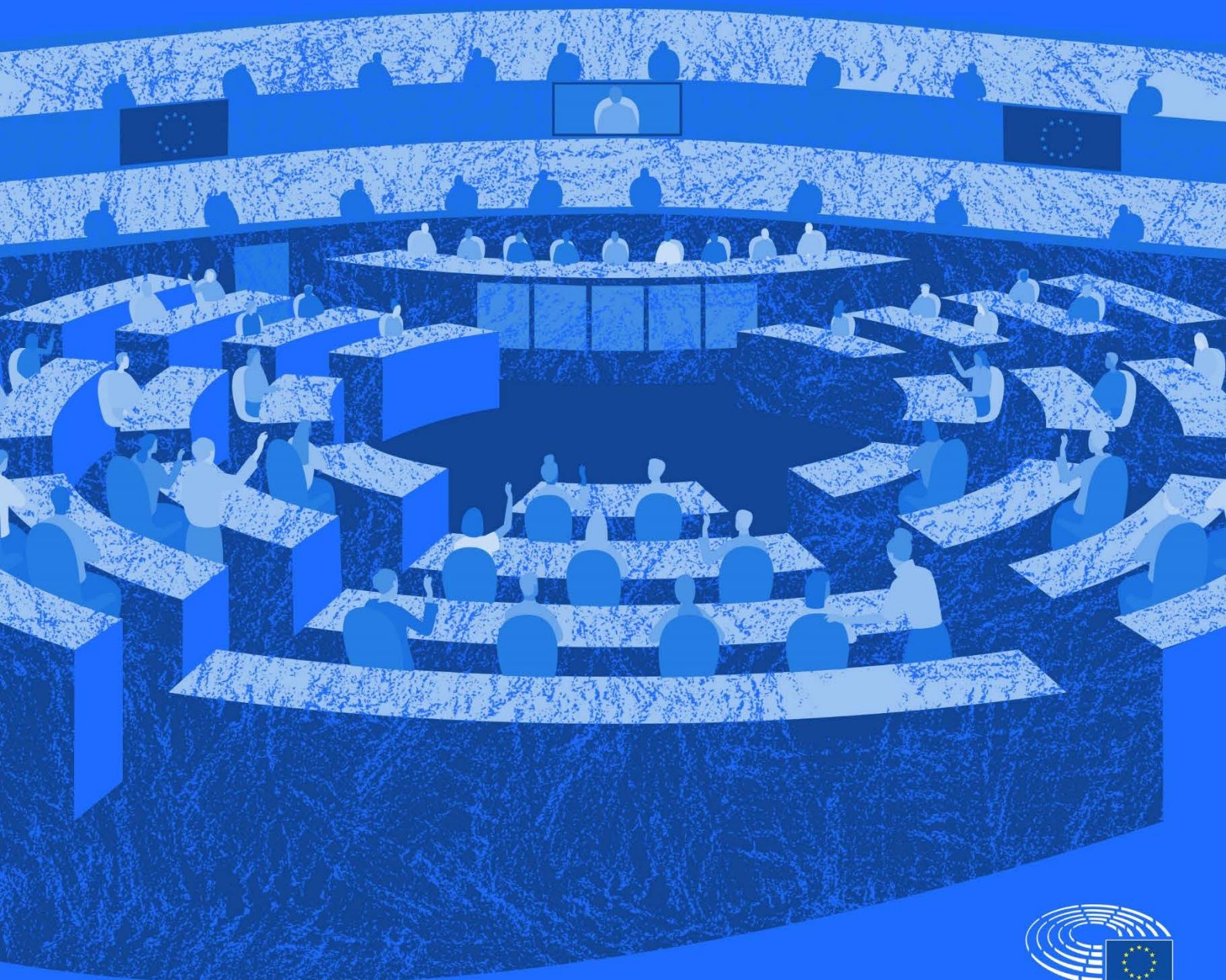

# 1. Main achievements of the Committee on International Trade (INTA) during the 9<sup>th</sup> legislature

---

The withdrawal of the United Kingdom from the EU, the Covid-19 pandemic, Russia's illegal and unprovoked war of aggression against Ukraine and increasing geopolitical tensions between the US and China substantially shaped the policy agenda of the Committee on International Trade (INTA) in the 9<sup>th</sup> parliamentary term. Confronted with these external shocks to world trade, INTA worked to flesh out the concept of **open strategic autonomy** through its legislative and non-legislative work, by protecting and advancing the Union's **multilateral, plurilateral and bilateral trade agenda**, and by closely scrutinising the proper **implementation and enforcement of existing trade legislation and agreements**. INTA substantially contributed to the adoption of a **legislative toolkit** in order to protect the Union from **unfair competition**, to **level the playing field** for Union companies, to **deter third countries from coercive behaviour** against the Union or its Member States and to defend its values and interests. INTA also ensured that **labour and sustainability obligations** would become part and parcel of all trade negotiations and contributed to ensure coherence and synergies between the common commercial policy, the **European Green Deal** and the Union's **digital strategy**.

## 1. Legislative achievements

---

Ever since the **Treaty of Lisbon** entered into force in December 2009, the EP has been acting as **co-legislator for the EU's trade-related legislation** together with the Council, under the **ordinary legislative procedure**. During the 9<sup>th</sup> parliamentary term the following dossiers are prominent examples of INTA's achievements in trade policy.

Confronted with continued impasse at the level of the World Trade Organisation (WTO) Appellate Body and its inability to hear new appeals as from December 2019, Parliament and Council adopted the **Enforcement Regulation**. The update to the 2014 Regulation was necessary to allow the EU to use countermeasures after it obtained a favourable ruling from a dispute settlement panel of the WTO while the other party appeals into the void. The EU is now in a position to retaliate with customs duties and quotas when its partners disregard trade rules and, at the same time, shun the arbitration mechanisms. The updated Enforcement Regulation entered into force on 13 February 2021.

Parliament and Council agreed to new rules for exports of **Dual-use items**. Dual-use items are goods, software and technology - for example, high-performance computers, drones and certain chemicals - with civilian applications that might be repurposed to be used in ways that violate human rights. The update to the Regulation became necessary due to technological developments and growing security risks. The Regulation sets up an EU-level coordination mechanism for the export of cyber-surveillance items, new transparency and reporting obligations for Member States, and will swiftly incorporate emerging technologies. The new Regulation entered into force on 20 August 2021.

In order to facilitate protected third country markets being opened up to EU economic operators, goods and services, Parliament and Council agreed on setting up an

**international procurement instrument (IPI)**, which introduces measures limiting the access to EU public procurement tenders of companies from non-EU countries that do not offer similar access to EU companies. The IPI tool, that had been originally proposed already back in 2012, empowers the Commission to determine whether companies from a third country must be subject to an IPI measure. The agreed Regulation finally entered into force on 29 August 2022. In April 2024 the Commission announced that it had initiated for the first time an investigation under the IPI.

In recent years, foreign subsidies appear to have distorted the EU's internal market, for instance by providing their recipients with an unfair advantage in the acquisition of EU companies or in obtaining public procurement contracts in the EU to the detriment of fair competition. In order to address this imbalance, Parliament and Council agreed to the **Foreign Subsidies Regulation (FSR)**. Prior to the FSR, subsidies granted by non-EU governments went unchecked, while subsidies granted by Member States are subject to close scrutiny under EU state aid rules. The new Regulation enables the Commission to investigate subsidies granted by non-EU public authorities to companies operating in the EU. If it finds that the subsidies are distortive, it can apply redressive measures. On 12 July 2023 the FSR started to apply.

The EU and its Member States have become the target of deliberate economic pressure in recent years. Building on Parliament's request in the negotiations over the Enforcement Regulation, in 2021 the Commission proposed the **Anti-Coercion Instrument (ACI)** as part of its new trade strategy. The instrument can be triggered by a wide range of coercive practices. Parliament managed to strengthen the ACI's deterrent nature by having a full list of possible responses in the Annex. The ACI entered into force on 27 December 2023.

The **Generalised Scheme of Tariff Preferences (GSP)** is a scheme that allows products originating in certain developing countries preferential access to the Union market. At the end of 2023 the Generalised Scheme of Tariff Preferences (GSP) was set to expire. In order to ensure continuity and legal certainty to third countries and importers, Parliament and Council agreed to the extension of the existing GSP Regulation, the so-called GSP rollover, until the end of 2027.

Parliament (led by INTA and Internal Market and Consumer Protection committee (IMCO)) reached an agreement with Council on the **Forced Labour** Regulation at the end of the term. The new Regulation creates a framework to ban products made with forced labour from the EU market including through investigations, new IT solutions and cooperation with other authorities and countries. If investigations by national authorities or the Commission conclude that forced labour has been used, the authorities can demand that the goods concerned be withdrawn from the EU market. The Regulation will soon enter into force and EU countries will have 3 years to start applying the new rules. INTA had been advocating for such an instrument for 10 years prior to its adoption and adopted in June 2022 a resolution detailing the elements that should be contained in the proposal.

Parliament and Council also agreed to more harmonised rules, which will put all imports, and a vast majority of exports, of firearms for civilian use under closer supervision, marking a crucial step in combatting **illicit firearm** possession and trafficking in the EU and globally. The updated rules will soon enter into force and will establish an EU-wide electronic licensing system for manufacturers and dealers replacing national systems. Competent authorities will be required to check the central system, containing all refusals, before granting an import or export authorisation.

In its legislative work, INTA has also been at the forefront of **support to Ukraine**. INTA dealt swiftly with the successive proposals to provide macro-financial assistance to Ukraine to the tune of EUR 25.2 billion. In the same vein, INTA Members supported the urgent suspension of EU import duties on Ukrainian goods in 2022 and renewed this in 2023 and 2024. Over the same period, given the economic repercussions of Russia's war of aggression against Ukraine, INTA also supported providing macro-financial assistance to **Moldova** in the order of EUR 295 million. As for Ukraine, INTA also approved trade support measures for Moldovan agricultural exports. With the outbreak of the COVID-19 pandemic, INTA also backed the proposal to provide EUR 3 billion of macro-financial assistance in the form of loans to 10 enlargement and neighbourhood partner countries.

## 2. Ongoing work and unfinished business

---

Despite having completed the bulk of its legislative workload, a number of proposals reached INTA too late in the legislature to be completed or the political divide with Council remained too wide to be bridged.

The Commission proposed updating the GSP Regulation in September 2021. Parliament and Council negotiators could not bridge the gap between the two institutions. In light of the impasse on the **GSP review**, Parliament and Council nonetheless agreed to the above-mentioned extension of the current system, the so-called GSP rollover, until the end of 2027.

On 24 January 2024, the Commission presented a legislative proposal for a revision of the Regulation on the **Screening of Foreign Investment into the EU** as part of its economic security package. The proposal aims to address the shortcomings of the 2019 FDI Screening Regulation thereby strengthening the protection of EU security and public order.

Among the files that were referred to INTA in the very last part of the legislature and for which no position has yet been reached in committee, there is a proposal for macro-financial assistance (MFA) of up to **EUR 4 billion for the benefit of Egypt**, as part of an overall MFA package of up to EUR 5 billion in loans to help the country confront its financing needs. In a similar vein, the Commission has also submitted a proposal to provide a new MFA of up to **EUR 500 million for the benefit of Jordan**.

## 3. Multilateral and plurilateral trade agenda

---

The European Parliament, and the INTA Committee in particular, have been strong supporters of the EU's continued efforts to advance a multilateral rules-based world trade order, and to overcoming the challenges to the WTO's dispute settlement system and its rule-making function, and therefore stood firm by the WTO and its parliamentary dimension as the centre of the international trade system.

Under INTA's leadership, the plenary adopted resolutions setting out Parliament's position ahead of the **12th WTO Ministerial Conference (MC12) in Geneva** in June 2022 and ahead of the **13th WTO ministerial conference (MC13) in Abu Dhabi** in February 2024 urging the Conferences to adopt a comprehensive package on institutional reform. A delegation of

INTA Members was part of the EU delegation to MC12 and MC13. In November 2019, Parliament also adopted a **resolution on the crisis of the WTO Appellate Body** and its position on how to move beyond the impasse. The EP continued to be a key actor in further strengthening the democratic scrutiny of the WTO via co-organising the **Parliamentary Conference on the WTO (PCWTO) ahead of MC13**. This brought together over 200 parliamentarians from all over the world. INTA Members also took part in all sessions of the **WTO public forum**. In the same vein, ahead of the appointment of **Dr Ngozi Okonjo-Iweala** as the new Director General of the WTO, INTA Members exchanged with the prospective candidate on 19 October 2020 in the framework of Parliament's Steering Group of the PCWTO.

Under the **plurilateral** heading, INTA kept scrutinising and monitoring plurilateral negotiations and the implementation of existing initiatives under the WTO, in particular those concerning **e-commerce, Trade and Gender, Investment Facilitation, Environmental Goods and the agreement on Government Procurement**. INTA also gave its consent to the **Services Domestic Regulation**, which was voted in plenary in November 2022. INTA was also actively involved in shaping the position of the Union and its Member States with regard to the **Energy Charter Treaty** (ECT). Parliament set out its position with regard to the ECT in the resolution on the future of EU international investment policy of June 2022. Together with the Committee on Industry, Research and Energy (ITRE), INTA was the committee responsible for the consent to the withdrawal of the Union from the ECT voted in the April 2024 plenary.

#### 4. Bilateral trade agenda

---

One of INTA's top priorities continued to be the scrutiny and monitoring of bilateral negotiations throughout the cycle, i.e. from the earliest steps ahead of negotiations up to the formal consent at the end of talks and the subsequent implementation of the agreements. During the 9<sup>th</sup> legislative term several free trade and investment agreements have been concluded and some entered into force.

At the very beginning of the legislative term, in February 2020, Parliament approved the **EU-Vietnam free trade and investment protection agreement** which entered into force on 1 August 2020. In the resolution which accompanied the consent, Members considered the agreement the most modern, comprehensive and ambitious agreement ever concluded between the EU and a developing country. A delegation of INTA Members travelled to Vietnam in October 2019 to exchange with government, legislators, civil society and stakeholders ahead of Parliament's consent.

The first part of the 9<sup>th</sup> legislature was marked by Brexit, as everything had to be translated into a clear settlement between the EU and the UK. INTA and AFET acting jointly provided recommendations on the negotiations for a new partnership with the UK. These were adopted in Parliament in June 2020. EU and UK negotiators agreed on the terms of the **Trade and Cooperation Agreement** (TCA) on 24 December 2020. To minimise disruption, the agreement provisionally applied between 1 January 2021 until 30 April 2021. For it to enter into force permanently, it required Parliament's consent which was granted on 28 April 2021. The scrutiny of Brexit negotiations as well as the work on the consent file have been a joint effort by INTA and AFET. A delegation of INTA Members visited Ireland and Northern Ireland on two occasions: in October 2022 and October 2023.



As a consequence of Brexit, INTA also dealt with a modification and consent to changes in the **Tariff Rate Quotas** (TRQs) with a number of third countries.

In November 2023, Parliament approved the pioneering **EU-New Zealand free trade agreement** (FTA). Described by MEPs as a “gold standard” agreement, this FTA is the EU's first to include enforceable commitments to the Paris Agreement and to core International Labour Organisation (ILO) standards. Negotiations had been launched in 2018, and after 12 negotiating rounds, a political agreement was reached on 30 June 2022. After the conclusion of negotiations and before formal consent, a delegation of INTA Members travelled to New Zealand and Australia in September 2022 to exchange with government, legislators, civil society and stakeholders on the FTA. The agreement entered into force on 1 May 2024.

In February 2024, Parliament approved the **EU-Chile Advanced Framework Agreement** (AFA) and the **EU-Chile Interim Trade Agreement** (ITA), which together constitute an updated version of the EU-Chile Association Agreement. The AFA consists of a political dialogue and cooperation pillar and a trade and investment pillar. It is complemented by an ITA, which includes only the trade and investment liberalisation elements of the AFA that fall under exclusive EU powers. This means that the ITA only needed to be ratified at EU level, while the AFA also needs to be ratified by all Member States individually. The ITA will then expire once the AFA enters into force. INTA was the committee responsible for the ITA and was jointly responsible for the AFA together with AFET. In his April 2024 report on the future of the Single Market, Enrico Letta specifically referred to the Chile ITA as an example to replicate for the ratification of future trade agreements. In view of the consent procedure, INTA Members travelled to Chile in May 2022 to exchange on the modernised agreement.

In February 2024, Parliament voted to give its consent to the **EU-Kenya Economic Partnership Agreement** (EPA) that aims to strengthen trade and economic ties with the African country, East Africa's main economic hub. It is the first agreement with a developing country in which the EU's new approach to trade and sustainable development is reflected. INTA Members travelled to Kenya in November 2022 in support of EPA negotiations.

Also in February 2024, Parliament also approved the **Sustainable Investment Facilitation Agreement (SiFA) with Angola** to bolster sustainable investment and trade. This is the first agreement on investment facilitation that the EU has negotiated. The deal is expected to improve the business climate in Angola, benefitting both foreign and domestic investors. The negotiations between the EU and Angola were concluded on 18 November 2022, and the agreement was signed on 17 November 2023.

In March 2024, Parliament voted to give its consent to the **EU-Japan deal on cross-border data flows**. The agreement will enable companies to handle data efficiently without cumbersome administrative or storage requirements, and provide them with a predictable legal environment in which to prosper.

**Trade cooperation with the US** also improved during this legislature, despite the absence of an overarching trade agreement between the two partners. INTA was at the forefront of the scrutiny of the work of the EU-US **Trade and Technology Council** (TTC) ensuring that relevant Members be briefed ahead and after each round of TTC negotiations. INTA also supported the opening of negotiations aimed at reaching an agreement with the US

on **critical minerals** (CMA) with the objective of redressing some of the discriminatory aspects of the Inflation Reduction Act for European exporters and backed negotiations on a **Global Arrangement of Sustainable Steel and Aluminium** (GSA). INTA Members travelled to Washington in October 2021 and another delegation went to San Francisco in October 2023.

In addition, INTA has taken an active role in monitoring a wide variety of ongoing bilateral trade negotiations, notably on **Australia, Indonesia and Mercosur**, the modernisation of the trade agreement with **Mexico** and the resumed negotiations with **India, Thailand and the Philippines**. In order to monitor and exchange on EU trade relations, delegations of INTA Members visited India (April 2022), Mexico (February 2022), Taiwan (December 2022), Brazil and Uruguay (May 2023), Indonesia (June 2023) and Thailand (December 2023). INTA also adopted reports setting out its position on a number of negotiations.

All in all, the work of the country or region-specific INTA Monitoring Groups was intensified, and the **Monitoring Groups** have proven to be a very effective tool in the parliamentary scrutiny of the Common Commercial Policy, allowing for in-depth and timely discussions on ongoing trade and investment relations as well as on the implementation of concluded trade agreements. In this context, INTA has cooperated with the relevant EP's parliamentary delegations, thereby, contributing to enhance parliamentary diplomacy.

## **5. Shaping and implementing the Common Commercial Policy**

---

In order to ensure a stronger democratic control on the conduct and pursuit of the strategic objectives of the EU trade policy, INTA spearheaded work on a number of non-legislative reports to set out Parliament's position on a number of priority areas. With the adoption of its resolution on the **EU Trade Policy Review** in November 2020, Parliament decisively shaped the Commission's communication on an open, sustainable and assertive trade policy of April 2021. Parliament's support was also instrumental in the Commission's review of the 15-point action plan on **trade and sustainable development**, which Parliament welcomed in its resolution of October 2022. INTA also weighed in on topical issues and negotiations notably through its report on **trade related aspects and implications of COVID-19** of July 2021, on the future of **EU-Africa trade** relations of June 2022, on the future of the Union international investment policy of June 2022 and on defining an **Indo-Pacific strategy** in the area of trade and investment of July 2022.

INTA also drew-up a number of implementation reports to evaluate the performance and suggest improvements to the existing networks of trade agreements with third countries. In October 2020, Parliament adopted its **implementation report on the Common Commercial Policy**. In February 2024, Parliament adopted an implementation report of the **EU-Southern African Development Community** (SADC) EPA, also building on the findings of INTA's visit to South Africa in April 2023. In January 2024, plenary also adopted the implementation report of the **EU-Canada Comprehensive Economic and Trade Agreement** (CETA), also following a fact-finding mission by INTA in June 2023. In November 2023, together with AFET and with input from 12 opinion-giving committees, Parliament adopted the first Implementation report on the **EU-UK Trade and Cooperation Agreement**.

INTA also organised regular exchanges on the conduct and implementation of EU trade policy and negotiations with Executive Vice-President **Dombrovskis**, with DG Trade Director General **Weyand** and with the Chief Trade Enforcement Officer **Redonnet**. INTA also maintained a continuous dialogue with the **EU's trading partners** by inviting on an *ad hoc* basis trade ministers and ambassadors of third countries for exchanges of views with Members of the committee. Moreover, INTA organised several delegation visits, public hearings, workshops, regular meetings with representatives of the civil society and Domestic Advisory Groups, other stakeholders as well as technical briefings on various topical aspects of trade-policy making to oversee either trade negotiations or the implementation of trade agreements.

Finally, yet importantly, in order to ensure inclusiveness in trade-policy making, INTA adopted its **2019-2024 Gender Mainstreaming Action Plan**. In accordance with the plan, INTA appointed three Members responsible for gender mainstreaming. They actively monitored gender mainstreaming in INTA committee's work and legislation. INTA also regularly organised dedicated committee debates on gender mainstreaming in trade and investment policy.
