7.1. ENVI hearing on Water resilience

The ENVI committee, by letter of 12 November 2024 to the CCC, requested competence clearance to organise on Monday 27 January 2025, afternoon (tbc), a public hearing on ‘The Way to a European Water Resilience Strategy - an EU Blue Deal’. This hearing “is to inform the drafting of the ENVI own-initiative report ‘The European Water Resilience Strategy’, which is preparing Parliament’s input on the future European Water Resilience Strategy.”

In his letter itself to the CCC, the ENVI Chair noted that AGRI Members will be invited to attend the hearing.

The draft programme of the hearing was annexed to the notes - see Annex II.

According to ENVI, “the hearing will look at the state of European water in general, as analysed by the European Environment Agency report of October 2024, followed by a discussion with other experts. It will also debate possible solutions, such as those proposed under the EU Blue Deal recommendations elaborated by the European Economic and Social Committee.”

7.2. Proposal of a Council decision amending Council Decision 2008/971/EC as regards the forest reproductive material of the ‘tested’ category

The proposal of a Council decision amending Council Decision 2008/971/EC as regards the forest reproductive material of the ‘tested’ category, its labelling and the names of the authorities responsible for the approval and control of the production is treated under simplified procedure according to rule 52 of RoP.

The draft report includes two amendments (one new recital and an amendment to article 2, 1) regarding the entry into force that will take place on the day of publication.
