of the meeting from Wednesday 4 December 2024 to Thursday 5 December 2024

Brussels

The meeting opened at 10:45, with Aurore Lalucq, Chair, presiding.

1. Adoption of agenda

Decision: The draft agenda was adopted in the form shown in these minutes.

2. Adoption of minutes

3. Chair's announcements

Interpretation facilities

The Chair made a brief announcement on the interpretation facilities available for the meeting.

Calendar of ECON meetings in 2025 – update

On 14 October 2024, ECON approved the calendar of ECON meetings in 2025. However, one update has become necessary, with a view to an efficient use of resources: the ECON meeting planned on Tuesday 28 January 2025 should be moved to Wednesday 29 January 2025. ECON Coordinators endorsed this update on 19 November 2024. Unless there are comments by the

end of today, this update will be considered approved by ECON.

Coordinators' meeting of 19 November 2024 - Summary of decisions and recommendations

1. Nominations

Coordinators agreed on the following:

- The file “*Administrative cooperation in the field of taxation (DAC 9)*” was allocated to the Bureau (Chair), and it was agreed to propose to follow a simplified procedure without amendments under Rule 52(1) RoP. The ECON Coordinators are shadow rapporteurs for this file.
- The file “*Common system of value added tax (VAT): rules for the digital age (VIDA) - Reconsultation*” was kept allocated to Renew without deduction of points, and it was agreed to propose to follow a simplified procedure without amendments under Rule 52(1) RoP.
- The ECON own-initiative report “Facilitating financing of investments and reforms to boost European competitiveness and creating a Capital Markets Union (Draghi Report)” was allocated to S&D.

2. AFET request for interim report on Andorra and San Marino

Coordinators agreed that ECON should request an opinion (Rule 57) on the interim report by AFET on the Association Agreement with Andorra and San Marino.

3. Own-initiative reports

There was a broad agreement to request authorisation to draw up own-initiative reports on the following topics:

- The impact of artificial intelligence on the financial sector; and
- Housing crisis in Europe: Economic drivers of the housing prices surge.

It was also agreed to request authorisation for an own-initiative report on “*Safeguarding and promoting financial stability amid economic uncertainties*” when a slot for an own-initiative report becomes available.

4. Economic Governance

European Fiscal Board (EFB) appointments: Coordinators agreed to hold a hearing with the candidate for the position of EFB Chair and to adopt reports on all appointments to the EFB

which will be then voted in Plenary.

5. Scrutiny of delegated and implementing acts

Coordinators decided to have a scrutiny slot on AMLD (jointly with LIBE).

6. Proposals for a Union Act

The Coordinators endorsed the following procedural approach:

- To invite the authors of the two proposals for a Union Act to present their proposals at the ECON meeting of 16 January 2025, because the authors were not available on 4-5 December 2024
- To invite Coordinators to decide at their next meeting or by written procedure whether further action is needed.

7. Motion for resolution

The Coordinators endorsed:

- the Coordinators' decision of 2015 on the process to be followed in relation to motions for resolution; and
- the suggestion not to follow-up on the motion for resolution tabled by João Oliveira (B10-0068/2024).

4. Report on ongoing interinstitutional negotiations

Better Data Sharing Regulation – Trilogue of 20 November 2024

Co-legislators held the first trilogue on the amending regulation as regards certain reporting requirements in the fields of financial services and investment support (Better Data Sharing Regulation) on 20 November 2024 (Rapporteur: Paulius Saudargas, EPP). The key political provisions were discussed, including the establishment of a Single Integrated Reporting System (SIRS), the scope of the data sharing and review clauses. With respect to the scope of the better data sharing regulation, the treatment of National Competent Authorities, the Single Resolution Board (SRB), the Anti-Money Laundering Authority (AMLA), the European Systemic Risk Board (ESRB) and the Single Supervisory Mechanism (SSM) were discussed. In addition, the type of information to be exchanged and the conditions for the exchange of information were addressed. A mandate to start technical work was given. The Commission was mandated to provide additional input on the Single Integrated Reporting System in preparation of the second trilogue, which is scheduled tomorrow, 5 December 2024.

Labour Market Statistics for Businesses – Trilogue of 21 November 2024

The first trilogue on Labour Market Statistics for Businesses took place on 21 November 2024 (Rapporteur: Irene Tinagli, S&D). Co-legislators discussed statistical units, sources and methods, quality of reporting and data requirements. It was agreed to delegate work to the technical level on these topics. Political discussions will continue at the next trilogue (date to be confirmed).

Benchmarks regulation review – Trilogue of 28 November 2024

The first trilogue on the Benchmarks regulation review (BMR) took place on 28 November 2024 (Rapporteur: Jonás Fernández, S&D). The co-legislators started their interinstitutional negotiations with the identification of major political issues. Topics discussed included the spot foreign exchange benchmarks, ESG-related benchmarks, significant benchmarks, ESMA supervisory powers and third country benchmarks, voluntary opt-in for benchmark administrators, and use of benchmarks. A mandate for technical work was agreed for some topics. The political discussions will continue at the next trilogue, which is scheduled on 12 December 2024.
