# **MINUTES**

**Meeting of Thursday 16 January 2025**

**Brussels**

The meeting opened at 9:06 with Aurore Lalucq, Chair, presiding.

**1. Adoption of agenda**

**Decision:** The draft agenda was adopted in the form shown in these minutes.

**3. Chair's announcements**

**Coordinators' meeting of 12 December 2024 - Summary of decisions and recommendations**

**1. Nominations**

Coordinators agreed the following:

- to allocate the ECON own-initiative report “*The impact of artificial intelligence on the financial sector*” to EPP;
- to postpone the allocation of the ECON own-initiative report “*Housing crisis in Europe: Economic drivers of the housing prices surge*”;

- to allocate the opinion on the file “*Implementation of the EU-UK Trade and Cooperation Agreement*” to the **S&D standing rapporteur on EU-UK relationship** (Eero Heinäluoma) (without deduction of points);
- **not to give an opinion** on the file “*Guidelines for the 2026 Budget - Section III*”;
- to allocate the file “*Draft general budget of the EU for the financial year 2026*” to the **Bureau** (without deduction of points); and
- to allocate the file “*Interim report on the Association Agreement with Andorra and San Marino*” to **EPP**.

## **2. Possible missions and visits in 2025**

Coordinators agreed to organise the following missions in 2025:

- Mission to the United Kingdom in February;
- Mission to Paris in April;
- Mission to Canada in May;
- Mission to USA in July; and
- Mission to the IMF annual meetings in October - USA.

It was agreed that each mission should include 7 Members.

In relation to RRF Working Group missions, a decision will be taken jointly with BUDG Coordinators on 20 January 2025.

## **3. Possible public hearings in 2025**

Coordinators agreed to organise the following public hearings in 2025:

- “*Implementation of Financial Sanctions: Making Better use of our Economic and Financial Instruments/frozen Russian assets under the sanctions package*”;
- “*Assessing the adequacy of the macro-prudential framework for non-bank financial institutions in the EU*”; and
- “*The impact of cryptocurrency markets on financial stability*”.

## **4. Anti-Money Laundering**

Coordinators agreed to organise the scrutiny slot with the Commission on the AML list of high-risk countries as an *in camera* meeting prior to the adoption of the delegated act. A decision on

further follow-up may be taken later, in light of developments.

## **5. Economic Governance**

### 1. Economic Dialogues with Member States:

Coordinators agreed to send invitation letters to the Finance Ministers of the eight Member States subject to an excessive deficit procedure and to identify a schedule.

### 2. Presentation of a set of studies assessing the strength and weakness of the methodical aspects of the Commission's Debt Sustainability (DSA) framework:

Coordinators decided that the studies should be presented at a meeting of the Working Group on the scrutiny of the implementation of the Economic Governance framework.

## **6. FISC Subcommittee**

1. ECON Coordinators endorsed the remaining parts of the summary of recommendations of the FISC Coordinators' meeting of 21 November 2024.

2. Going forward, FISC Coordinators' summaries of recommendations shall be endorsed by written procedure.

## **7. ECONINI report on CMU - possible EESC opinion**

Coordinators agreed that the EESC should be requested to draw up an exploratory opinion in relation to the INI report on "*Facilitating the financing of investments and reforms to boost European competitiveness and creating a Capital Markets Union (Draghi Report)*".

## **8. Motion for resolution**

Coordinators endorsed not to follow-up on the motion for resolution B10-0155/2024.

## **9. Petitions**

Coordinators endorsed the guidelines for the handling of petitions and the assessment of Petition No 0696/2024.

## **10. Any other business**

It was agreed to organise a scrutiny slot on Solvency II and IRRD in February.

**Decision taken by Coordinators in written procedure (deadline 8 December 2024)**

ECON Coordinators endorsed the summary of decisions and recommendations of the FISC Coordinators' Meeting of 12 December 2024.

**Report on ongoing interinstitutional negotiations**

**1. Better Dating Sharing Regulation: Trilogues of 5 and 17 December 2024**

The second and third trilogue on a Regulation amending certain financial services and investment support regulations as regards certain reporting requirements (Better Data Sharing Regulation) took place on 5 and 17 December 2024 respectively (Rapporteur: Paulius Saudargas, EPP). In the trilogue on 17 December 2024 the co-legislators reached a provisional political agreement. The provisional agreement includes *inter alia* the following:

Besides the three European Supervisory Authorities (ESAs), the Single Supervisory Mechanism (SSM), the Single Resolution Board (SRB), the European Anti-Money Laundering Authority (AMLA) and the European Systemic Risk Board (ESRB) are included in the scope of this amending regulation.

It was also agreed that the authorities in scope would strive for the 'report once' principle, so that information from financial institutions and other reporting entities is only reported once to one of these authorities.

Within five years the ESAs through the Joint Committee, in close cooperation with ESRB, ECB, the AMLA, the SRB and the competent authorities, will prepare a report on the feasibility of a cross-sectoral integrated reporting system and based on this, lay out a roadmap for the implementation. Taking into account the report the Commission shall, where appropriate and necessary, submit a legislative proposal.

A mandate was given to the technical level to finalise the legal text.

**2. Labour Market Statistics for Businesses – Trilogue of 12 December 2024**

The second trilogue on Labour Market Statistics on Businesses (LBM) was held on 12 December 2024. The co-legislators reached a provisional agreement on the remaining political issues, namely on safeguards, temporary data and derogations. Co-legislators also endorsed the work done at technical level ahead of the trilogue. We will be voting on the provisional agreement under point 5 of today's agenda.

### **3. Benchmarks regulation review (BMR): Trilogue of 12 December 2024**

The second trilogue on the Benchmarks regulation review (BMR) took place on 12 December 2024. The co-legislators reached a provisional agreement on the remaining political issues and endorsed the work done at technical level ahead of the trilogue. Negotiators agreed that the new rules should apply to critical benchmark, significant benchmark and certain commodity benchmark as well as climate-related benchmark such as EU climate-transition and EU Paris-aligned benchmark in order to ensure adequate supervisor. They also agreed to opt in regime and ensure that ESMA would have a supervisory role over administrators endorsing benchmark provided in a third country. Co-legislators gave a mandate to the technical team to implement the provisional agreement. We will be voting on the provisional agreement under point 6 of today's agenda.

### **4. CMDI package - Trilogues of 17 December 2024 and 14 January 2025**

On 17 December, a first trilogue was held and failed to adopt the agenda but the second trilogue on 14 January had managed to do so and the work is underway.
