Meeting of 14 October 2024, 17.00-18.45

BRUSSELS

The meeting opened on Monday 14 October 2024 at 17.12, with Antonio Decaro (Chair) presiding.

1. Adoption of agenda

- **Corrigenda (Rule 251)**

The secretariat has received a corrigendum regarding the position of the Parliament adopted at first reading during the 9th parliamentary term. Members had received this document by email on Thursday, 10 October 2024.

In line with Rule 251 of the Rules of Procedure, Parliament needs to scrutinise and approve the following corrigendum:

- Regulation (EU) 2024/... of the European Parliament and of the Council establishing a Union certification framework for permanent carbon removals, carbon farming and carbon storage in products - 2022/0394(COD)

As no objection was raised by a political group nor five Members within the deadline (Friday, 11 October 2024 at 13:00), the corrigendum was approved by the ENVI committee and was announced at the following plenary session.

3. Chair's announcements concerning coordinators' recommendations of 7 October 2024

The coordinators' recommendations of Monday, 7 October 2024 had been circulated electronically to all ENVI Members.

Jana Nagyová took the floor on behalf of the Patriots for Europe Group to contest the coordinators' decision on item 3.2 (*Appointment of contact persons for the Agencies within ENVI remit and ENVI representatives in networks and other bodies*) of the coordinators' agenda. The contestation concerned this item only, and the group did not contest the remaining decisions taken on 7 October.

This contestation would be put to the vote at the next ENVI Voting session, which is due to take place at the extraordinary committee meeting in Strasbourg, on Monday, 21 October at 19:00.
