1. Expresses serious concern over the lack of focus on protecting women and girls from ***any form of*** violence in the Union budget; regrets the absence of disaggregated data on gender-based violence and urges ***the proper and prompt***

specifically aimed at protection against violence to enable monitoring of the effectiveness of the measures in relevant legislative acts;

implementation of Art 44 of the directive on combating violence against women and domestic violence^{1a} ; asks the Commission and the Member States to explore the feasibility of enlarging and improving the data collected, particularly to prevent repeat or predictable offences, as soon as possible and in any case in any new legislation and reviews; urges mandatory gender impact assessments aimed at protection against violence to enable monitoring of the effectiveness of the measures in relevant legislative acts;
