The meeting opened on Wednesday 4 December 2024 at 10:42, with Lina Gálvez (Chair) presiding.

**4 December 2024, 10:30-12:30**

**1. Adoption of agenda**

FEMM\_OJ(2024)1204\_1

The agenda was adopted.

**2. Chair's announcements**

In their meeting on 14 October 2024, the FEMM coordinators decided:

- that the following FEMM INIs should be requested for authorization:

- Gender pay and pension gap in the EU: state of play, challenges and way forward and developing guidelines to better evaluate and fairer remunerate work in female dominated sectors,
- Gender Equality Strategy 2025,
- Importance of consent based rape legislation in the EU,

- Women's entrepreneurship in rural, insular areas and outermost regions,
  - Gender inequalities in health and gender-specific conditions,
  - Advancing towards care society: Addressing the gender care gap,
- to allocate to ECR the standing rapporteur for the budget and discharge procedures for the first half of the parliamentary term, for 1 point;
  - to appoint joint co-rapporteurs Renew-Greens for the standing rapporteur for gender mainstreaming, for 2 points (subject to authorization by the CoP of the co-rapporteurship), 1 point per group;
  - to allocate to the EPP the standing rapporteur for the monitoring of the implementation of the Istanbul Convention, for 2 points;
  - to continue with the practice of FEMM liaison Members for relations with EIGE and for a Working Group on EIGE to be created. Coordinators also decided to appoint one Member from S&D as a liaison Member and postponed the appointment of the second Member;
  - that FEMM would request the ad-hoc delegation to the 69th session of the UN CSW consisting of 10 Members, including the Chair. They decided that if possible, the delegation should comprise representatives of all political groups;

In their written procedure on 16 October 2024, the FEMM coordinators decided:

- to organise following four hearings in the first half of 2025:
  - Social media and the consequences on young girls' mental health - 28 January 2025
  - Combatting Menstrual Poverty and Improving Women's Rights on Menstrual Health - 18 February 2025
  - Hearing on chemical submission - 9 April 2025
  - Image based sexual violence in the context of AI and social media specifically exploring the role of undressing apps and the responsibilities of platforms. - 20 May 2025
- agreed on the personalities that FEMM would propose to invite to the plenary celebration of IWD 2025;
- to organise a mission to Slovakia in February and to Cyprus in May. The missions will be requested for 9 Members plus the Chair.

In their written procedure on 8 November 2024, the FEMM coordinators decided:

- to allocate the FEMM opinion on the Proposal for a Directive on combating the sexual abuse and sexual exploitation of children and child sexual abuse material to the S&D, for one point;
- agreed on the speakers to be invited to the FEMM hearing on addressing the challenges faced by women with disabilities in healthcare, employment, societal participation;
- agreed to the presentation of the UNODC 2024 Global Report on Trafficking in Persons jointly with LIBE;

In their written procedure on 18 November 2024, the FEMM coordinators decided:

- to endorse the FEMM oral question on the EU priorities for the CSW69;
- agreed on substitute speakers to be invited to the FEMM hearing on Securing gender equality and women's rights in the digital sphere.
