Meeting of 17 October 2024, 09:00-12:30

The meeting opened on Thursday 17 October 2024 at 09:00, with Pasquale Tridico (Chair) presiding.

17 October 2024, 9.00 – 10.30

1. Adoption of agenda

Decision: The draft agenda was adopted.

2. Chair's announcements

Interpretation

The Chair made a brief announcement on the interpretation facilities available for the meeting.

Main decisions of the Coordinators at their meetings of 24 July, 12 September, and 3 October:

- 1) The Coordinators agreed to hold in the coming FISC Subcommittee meetings:
 - Exchange of views with the Commission, OECD and UN to exchange on the state of play and the future of European and international tax policy;

- Exchange of views with the Brazilian Finance Minister Fernando Haddad to discuss the progress made on taxation in the course of the Brazilian Presidency of the G20;
 - Exchange of Views with María José Garde, Chair of the Code of Conduct Group on Business Taxation;
 - Exchange of Views with Ms Laura Kövesi, Chair of the European Public Prosecutor’s Office (EPPO);
- 2) The Coordinators also confirmed their wish to co-organise the next EU Tax Symposium with the Commission. The date is not yet fixed but it could take place in Spring 2025 (possibly on 18 March). The practical modalities will be decided once the new Commission will have started its mandate.
- 3) They drafted written questions in preparation of the hearings of the Commissioners designated in charge of taxation, namely Mr Hoekstra and Mr Dombrovskis. The FISC Subcommittee will be involved in the hearings of these candidates with the FISC Chair being invited to ask one oral question to the candidates.
