- and additionally to request the following in the frame of the 2025 Annual Research programme: studies on the 28th Regime and on civil law in the Digital Single Market; a study and workshop on AI and copyright; a briefing on reporting obligations; and to organise the following missions in 2025 to: Luxembourg (CJEU); Alicante (EUIPO); Geneva (WIPO); Munich (EPO); Ljubljana and Antwerp;
- to follow up the motion for a resolution on introducing competitiveness mainstreaming for EU legislation (B10-0155/2024) in the context of future committee work;
- to appoint Pascale Piera as rapporteur for the opinion on Establishing harmonised requirements in the internal market on transparency of interest representation carried out on behalf of third countries (2023/0463(COD)) and Ilhan Kyuchyuk as rapporteur for the opinion on The Commission's 2024 Rule of Law report (2024/2078(INI)).
